- 1) Silver Warehouse Receipts #PR0201 through #PR05000 are reserved as proofs and have not been issued.
- 2) Silver Warehouse Receipts #SP05001 through #SP10000 are reserved as specimens, are not backed by silver, and not subject to audit.
- 3) Silver Warehouse Receipts #A010000 through #A017000 are reserved for special collector issues at a later date.
- 4) Silver Warehouse Receipts #D232601 through D232800 were destroyed in production.
- 5) Silver Warehouse Receipts #D235601 through D235800 were destroyed in production.
- 6) Gold Warehouse Receipts #PR00001 through #PR00012 are reserved as proofs and have not been issued.
- 7) Due to higher silver prices, the Face Value (FV) of the 500 ounce Digital Warehouse Receipt (DWR) has been revised from \$5,000 to \$10,000 as the Liberty Dollar moved up from the \$10 Silver Base to the \$20 Silver Base. As of November 24, 2005, all existing Liberty Dollar accounts were also doubled as twenty Liberty Dollars, and now backed by one Troy ounce of .999 fine silver.
- 8) Due to higher gold prices, the Face Value (FV) of the one ounce Gold Warehouse Receipts has been revised from \$500 to \$1,000 as the Liberty Dollar moved up from the \$500 Gold Base to the \$1,000 Gold Base.
- 9) Two Digital Warehouse Receipts #00053 and #00054 were void on June 18, 2004.
- 10) Due to higher silver prices, the Face Value (FV) of the one ounce Silver Warehouse Receipts has been revised from \$10 to \$20 as the Liberty Dollar moved up from the \$10 Silver Base to the \$20 Silver Base.
